1. Background

The Hagerstown Children's School, located at 22 N. Mulberry Street, has requested that the City designate the area near the school as a Drug-Free school zone. As mentioned in the attached request letters from the school and from Aaron Peteranecz, the owner of Mulberry Lofts where the school is located, there has been continued drug use in the vicinity of the school. The Hagerstown Children's School, an approved kindergarten provider, is concerned about the safety of its students, and the safety of their parents who pick-up and drop-off their children at the school.

2. Mayor & Council Action Requested

Review this information, determine whether or not to designate the area around the Hagerstown Children's School as a Drug-Free school zone. If the Council is in agreement, staff will work with the City Attorney to prepare and introduce an ordinance to amend the City Code as required. Staff will be present at the work session to discuss.

3. <u>Discussion</u>

Chapter 25 of the City Code deals with Drug-Free school zones, and references the Maryland Annotated Code. The statute creates 1,000 ft. zones around identified schools where the possession and/or use of drugs and other substances is prohibited. The designation gives law enforcement additional abilities to control the use of drugs in these zones. If the Council is in agreement with the creation of a new zone around the Hagerstown Children's School, the City will amend the map showing the Drug-Free school zones to include the new zone.

We are writing to bring to your attention a matter of significant concern regarding the safety and wellbeing of the children attending Hagerstown Children's School, a private, not-for-profit early education program housed within Mulberry Lofts at 22 North Mulberry Street. As an organization deeply invested in the welfare of our students, we urge you to consider the rezoning of the area surrounding Mulberry Lofts and the additional parking lot located at approximately 227 E. Washington St. as a drug-free school zone.

Hagerstown Children's School, which services an MSDE-approved kindergartener program as well as preschool children ages two through five, is celebrating its thirtieth anniversary this school year. We have consistently provided a high-quality and cost-effective early education program to Hagerstown and the surrounding areas. Our strong reputation is further confirmed by being named the Tristate area's Best Private School for 2023 through VerStandig Media. Throughout the past three decades, we have remained committed to our city and chose to participate in downtown Hagerstown's revitalization movement by relocating our school to Mulberry Lofts in 2017.

However, over the past six years, we have faced growing problems that pose an immediate threat to the safety of our students and families. The protection of our children should always be our highest priority, and unfortunately, the presence of drug-related activities in close proximity to educational institutions poses a serious threat to their security and overall well-being. Despite the best efforts of our landlord and the Design Method Group, we are receiving increasing reports of drug use, used needles, as well as other drug paraphernalia in our building, walkways, and parking lots. By designating the area around Hagerstown Children's School as a drug-free school zone, we can take proactive measures to protect our children from exposure to drugs and related criminal activities.

To date, we have been working closely with Sergeant Casey Constable, Downtown Supervisor for Hagerstown Police Department (HPD), and his officers to increase police presence at drop off and pick up, when our students are most often utilizing the neighboring sidewalks, alleys, and parking lots. While we are deeply grateful for the support of Sergeant Constable and HPD, our officers are undeniably outnumbered by the vast cityscape and the diverse areas of need. Rezoning the area as a drug-free school zone would align with existing laws and ordinances aimed at safeguarding children and promoting a safe learning environment. Such a designation would ensure the health, safety, and well-being of all populations.
