City Revitalization Improvement Zone (CRIZ):

Enabling Legislation for a new Economic Development Financing Tool City of Hagerstown

Description

The City of Hagerstown serves as the economic core of Washington County, and downtown redevelopment efforts which strengthen the core result in strengthening the region. A City Revitalization Improvement Zone (CRIZ) is a powerful economic development financing tool which could support and attract new, private development activity.

A CRIZ is similar to Tax Increment Financing (TIF), and may be likened to a "Super TIF." It is a more powerful financing tool because it utilizes a broad array of taxes. As the funding source for the CRIZ is new tax revenue as a result of business attraction, the program is cost neutral to the State budget

Replicable Model from the State of Pennsylvania

In 2011, Allentown, PA became the first city in the State of Pennsylvania to pilot Neighborhood Improvement Zone (NIZ) legislation. In 2013, state-wide legislation was enacted enabling City Revitalization Improvement Zones for cities with populations greater than 30,000.

Allentown's NIZ is located in the approximately 130 acres in the City Center and along the Riverfront. The first project for Allentown's NIZ was "PPL Center," an 8,500 seat multi-purpose hockey arena, and home to the Allentown Phantoms, an affiliate of the Philadelphia Flyers. The initial bonds issued in 2011 started the NIZ, and the arena opened in September 2014. The PPL Center Arena is wrapped by retail, offices and a 180-room Marriott Renaissance Hotel. The Dime Bank Building, a historic Art-Deco period building, was renovated for part of the hotel.

The City Center Investment Corporation (CCIC) is a private, for-profit real estate development and management company created in 2011. The company co-owners are local developers J.B. Reilly and Joe Topper who are making a \$400 million investment in Downtown Allentown. City Center Investment Corporation (CCIC) Projects include: 350 new luxury apartments, 650,000 square feet of Class A office space and 50,000 square feet of upscale retail and restaurant space.





How it Works

The state-wide CRIZ legislation only allows eligibility to new businesses attracted from outside the State of Pennsylvania. As the funding source for the CRIZ is new tax revenue as a result of business attraction, the program is cost neutral to the State budget. The original Allentown NIZ allowed for business relocation within the region and the State. Developers have a non-poaching policy, and attract through value proposition.

The following provides detail on the possible mechanics of a similar program in the State of Maryland based on the Pennsylvania NIZ and CRIZ models.


- Eligible applicants: For Profit; Non Profit; Individuals; Joint Ventures
- Taxes eligible to be pledged to fund development (under CRIZ) include: corporate net income tax; capital stock franchise tax; sales and use tax; personal and earned income tax; business privilege tax; amusement tax; liquor tax; bank share tax
- Real property taxes are not eligible to be pledged to fund development costs (under CRIZ), but a potential development could potentially seek both CRIZ and TIF financing.
- Eligible tax amount is limited to the excess of tax collected in future years (increment) over the baseline tax paid in the year in which the CRIZ is created.
- Just qualified taxes for all of the NIZ projects are forwarded from the State to the Authority in a single payment once per year. It is then up to the Authority to identify which projects get what portion of the returned taxes. This is not all taxes from all properties located in the NIZ, but just qualified taxes for NIZ projects.
- The maximum duration is proposed in Maryland to be 20 years.
- The financing tool is not risk-free to the developer. If tenant tax revenues fall short, the developer is responsible for paying the difference to the lender.
- Business owners located in the NIZ area do not incur any additional taxes because of the NIZ, but are required to complete NIZ reporting forms annually.

The NIZ is managed by Allentown Neighborhood Improvement Zone Development Authority (ANIZDA), an authority of the City. It is staffed by the City's Director of Community and Economic Development.

Flow of Funding

The following chart shows the flow of funds for NIZ projects. The steps in the process include: 1. Determine future incremental increase in tax revenue; 2. Determine level of financing that can be leveraged using future tax

revenue as collateral; 3. Apply to the Authority for qualification of proposed project; 4. Finalize terms with financing institution and the Authority; 5. Build the project; 6. Once in operation, payment of taxes used to pay down debt on financing.



Readiness of Hagerstown to Serve as a Pilot City

Momentum is underway in the redevelopment of Downtown Hagerstown. Investor confidence is strong, and Hagerstown is at an opportune time with demonstrated readiness to support new growth.

In July 2014, the City of Hagerstown released the Community's City Center Plan, a 10-year downtown redevelopment plan which is the is the result of more than 130 hours of broad community input. The Community's City Center Plan is a roadmap for eight catalyst projects that will spur development in Hagerstown's City Center, and includes detailed annual steps for making these concepts a reality. It creates at least 875 new permanent jobs, bringing \$125 million in new investment downtown. This is a public-private partnership, where private developers invest 75% of the cost while funding from all levels of government will cover the rest. The City's consultants, Urban Partners, conclude that all of these projects are feasible based on their economic analysis.

To date, the City of Hagerstown estimates \$71.8 million in new investment has occurred in Downtown Hagerstown, between 2003 and 2013. A total of \$7.57 million in new investment is under construction, and an additional \$740,000 in new investment is planned and announced.

We request the drafting and passage of enabling legislation in the State of Maryland to allow the City of Hagerstown to serve as a pilot city for a City Revitalization Improvement Zone (CRIZ).

The United States of America Vietnam War Commemoration

In accordance with Public Law 110-181 SEC.598, Congress authorized the Secretary of Defense to conduct a program to commemorate the 50th anniversary of the Vietnam War and "in conducting the commemorative program, the Secretary shall coordinate, support, and facilitate other programs and activities of the Federal Government, State and local governments, and other persons and organizations in commemoration of the Vietnam War."

To that end, The United States of America Vietnam War Commemoration was formed. The congressionally-mandated objectives for the Commemoration are:

- 1. To thank and honor veterans of the Vietnam War, including personnel who were held as prisoners of war, or listed as missing in action, for their service and sacrifice on behalf of the United States and to thank and honor the families of these veterans.
- 2. To highlight the service of the Armed Forces during the Vietnam War and the contributions of federal agencies and governmental and nongovernmental organizations that served with, or in support of, the Armed Forces.
- 3. To pay tribute to the contributions made on the home front by the people of the United States during the Vietnam War.
- 4. To highlight the advances in technology, science, and medicine related to military research conducted during the Vietnam War.
- 5. To recognize the contributions and sacrifices made by the allies of the United States during the Vietnam War.

One of the major ways the Commemoration plans to accomplish these objectives is by recruiting Commemorative Partners throughout America. The Commemorative Partner Program is designed for federal, state and local communities, veterans' groups, and other nongovernmental organizations to assist a grateful nation in thanking and honoring our Vietnam Veterans and their families.

It costs nothing to become a Commemorative Partner. Commemorative Partners participate by planning and conducting events and activities that will recognize and honor the service, valor, and sacrifice made by Vietnam Veterans and their families. America has a strong tradition of honoring veterans and their families on key dates, such as Memorial Day, National POW/MIA Day, and Veterans Day. The United States of America Vietnam War Commemoration Commemorative Partner Program

The Commemorative Partner Program is designed for federal, state and local communities, veterans' organizations and other nongovernmental organizations to assist a grateful nation in thanking and honoring our Vietnam Veterans and their families. Commemorative Partners participate in the Commemoration by planning and conducting events and activities that recognize Vietnam Veterans and their families' service, valor, and sacrifice. Commemorative Partners must commit to conduct two events each year from 2015–2017.

Commemorative events and activities should be dignified, memorable occasions that show a sensitivity and appreciation for the solemnity of war and the losses suffered by many. Events or activities should meet one or more of the congressionally-mandated objectives of the program, and as a minimum, with an emphasis on objective one:

1. To thank and honor veterans of the Vietnam War, including personnel who were held as prisoners of war or listed as missing in action, for their service and sacrifice on behalf of the United States and to thank and honor the families of these veterans.

To highlight the service of the Armed Forces during the Vietnam War and the contributions
of Federal agencies and governmental and nongovernmental organizations that served with,
or in support of, the Armed Forces.

3. To pay tribute to the contributions made on the home front by the people of the United States during the Vietnam War.

4. To highlight the advances in technology, science, and medicine related to military research conducted during the Vietnam War.

5. To recognize the contributions and sacrifices made by the allies of the United States during the Vietnam War.

It <u>costs nothing</u> to become a Commemorative Partner. To become an official Commemorative Partner, organizations must submit an application and a signed Statement of Understanding. To obtain an application go to <u>www.VietnamWar50th.com</u> and then to the Commemorative Partner Program webpage for further information on how to apply. Once an application is submitted, the approval process should take no longer than 30 days. Partners are kept informed of an application's status through electronic notifications. Once approved, the Commemoration will provide the Commemorative Partner with a starter kit composed of materials for developing and implementing their programs. Commemorative Partners receive a commemorative flag, Commemorative Partner certificate and other materials, and authorization to use The United States of America Vietnam War Commemoration Commemorative Partner seal for approved purposes.

Vietnam Veteran Lapel Pin ... a lasting memento of the nation's thanks!

- <u>Purpose</u>: To recognize, thank and honor United States military veterans who served during the Vietnam War period.
- <u>Eligibility</u>: Living United States veterans who served on active duty in the U.S. Armed Forces from November 1, 1955 to May 15, 1975, regardless of location, are eligible to receive one lapel pin.
- Presentation: These lapel pins will be presented in a dignified manner to
 each Vietnam veteran during public events held in their communities by
 Commemorative Partners. Accompanying remarks should reflect the nation's
 thanks for their service and sacrifice. In the rare instance when an honoree
 cannot attend a public event, the pin may be presented during a private
 ceremony.

Symbolism:

Eagle – The eagle represents courage, honor and dedicated service to our nation. As one of the most recognizable and notable American symbols, it is emblazoned with distinction on numerous military insignia.

Blue Circle – The color blue matches the canton of the American flag and signifies vigilance, perseverance and justice. The circle shape and blue color also match the official seal of the Commemoration.

Laurel Wreath - A time-honored symbol representing victory, integrity and strength.

Stripes - The stripes behind the eagle represent the American flag.
 Stars - The six stars represent the six allies who served, sacrificed and

fought alongside one another: Australia, New Zealand, the Philippines, the Republic of Korea, Thailand, and the United States.

 Message - "A Grateful Nation Thanks and Honors You" is embossed on the back, closest to the heart of the wearer, along with the Commemoration's name.
