Re: Federal JAG application (2015-DJ-BX-0765) in the amount of \$16,523.00.

In June of 2015, we applied for, and later received, a Federal JAG application (2015-DJ-BX-0765) in the amount of \$16,523.00. A requirement of that application was to notify the governing body. We fulfilled one requirement by posting the solicitation on the City website on or about June 16, 2015. Council notification was not completed and is being completed with this agenda item.

With that being identified, this grant is a yearly non-match grant that we have received for numerous years and provides overtime funding to support strategies within designated "Safe Streets" areas and public housing. Currently the grant has been frozen until the requirement to notify the Council is complete.

Strategies may include but are not limited to:

- Law enforcement activities may include, but are not limited to, drug operations, traffic operations, prostitution operations, and any other activity that is law enforcement related and evidence-based in this area.
- Since the City's budget is based on projections from previous incidents and does not reflect specialized activities which are based on future, specific problems, these funds are potentially vital to the department.



Topic:

Memorial Park Circle of Achievement - Class of 2016 - Stephen Bockmiller, Development Planner and Zoning Administrator

Mayor and City Council Action Required:

To review the list of recommended honorees and select two to four for the Class of 2016. While there are funds sufficient for four plaques, the Committee recommends adopting no more than two honorees per year to maintain the exclusivity of the honor and not work through the pool of candidates too quickly.

Discussion: BACKGROUND:

The City dedicated Memorial Park in 2015. One component of this park is the "Circle of Achievement" – an outdoor "hall of accomplishment" of Hagerstown residents. High standards were adopted by the Mayor and Council and an initial database of 45 potential honorees was compiled by the Memorial Park Circle of Achievement Inductee Review Committee. In 2015, in order to create an initial "critical mass" of honorees, the Mayor and Council adopted an initial class of 12 inductees. Initially the first class was intended to include eight inductees. The Committee offered 10 recommendations for the first class for consideration. The Mayor and Council adopted all ten, added an 11th (William O. Wilson) and requested the Committee to recommend a twelfth who was a Union veteran of the Civil War. The Committee returned with a recommendation of Col. Edward Mobley as the twelfth honoree, and the elected officials adopted the slate of twelve inductees. The induction ceremony was held on May 16. Descendants of 10 of the 12 honorees were present and they came from literally all over the country to participate.

UPDATING THE DATABASE:

The database of potential honorees can be updated at any time by the Committee when persons meeting the established criteria are identified. Suggestions and requests for consideration are welcome. No new potential honorees were identified by the Committee or staff in the last 12 months. Three suggestions/ requests were made by others for the Committee's consideration. Of these, one – former Mayor Winslow F. Burhans met the criteria and the Committee added Mayor Burhans to the database.

RECOMMENDATIONS FOR THE CLASS OF 2016:

The City Engineer advises that there is money in the budget for two to four plaques, depending upon how the Mayor and Council desires to proceed. After reviewing the potential candidates available on the adopted database of qualified persons for consideration, the committee recommends that the Mayor and Council consider the following persons for inclusion in the class of 2016:

1. **Peter Buys (1881 – 1964)** – Criteria C.2 – Buys was the director of the Hagerstown Municipal Band for nearly four decades (1920-1959). He was a protégé of John Philip Sousa and an arranger for the Sousa Band. Buys is considered one of the giants in the "march" genre of music.

2. **Maurice E. Frock (1898-1918)** – Criteria D.2.c – Frock served in the U.S. Marine Corps and fought in the Belleau Wood Battles of World War I. He earned the equivalent of two Silver Star Medals within days of one another. The first was for actions in battle during the period of June 6 – 10, 1918. The second was for attempting to run important dispatches to superiors through the battlefield while under heavy fire from German artillery in June 12. He was killed in action as a result. It is reported he also earned the French Croix du Guerre Medal, and we will attempt to verify this. Frock Post of the American Legion carries his name.

3. **Clara Jenness Hamilton (1837-1919)** – Criteria E.2 – Hamilton was the developer of the tract of land which has since become the Oak Hill Historic District. An early proponent of the "Garden City" movement, the principals of that form of landscape design heavily impacted the ultimate design of the Oak Hill development. Hamilton was a rare example of a female land developer during the period around the turn of the 20th Century and her work has forever impacted the character of the northern quarter of the city.

4. **Thomas W. Pangborn (1880-1967)** and **John C. Pangborn (1883-1959)** (one plaque) – Criteria E.2. The Pangborn brothers led one of the largest and most successful businesses in the history of the City. The Pangborn Corporation operated at its Pangborn Boulevard facility from 1915 to 1963 and at its height employed over 1,000 persons. Sold in 1963, the corporation continued to operate here until 2000, and then moved its headquarters in 2008. Their philanthropic efforts also greatly impacted various City and county institutions including the Washington County Hospital, St. Mary's School, St. Ann's Catholic Church and Pangborn Park, as well as others institutions outside the immediate area as well. Thomas was the first American to be named a "Papal Count" by the Roman Catholic Church, and he was named one of the 16 leading industrialists in the United States by *Iron Age* magazine.

5. **James Dixon Roman (1809-1867)** – Criteria E.2 – Roman served as a U.S. Congressman during the same period that Abraham Lincoln served in the House of Representatives (1847-49). Roman served as the President of the Hagerstown Bank (the largest bank in Washington County) from 1851 to 1867. He was the primary person actor who developed and successfully arranged for the successful strategy that met the Confederate ransom demands and saved the city from destruction in 1864.

OTHER RECOMMENDATIONS AND COMMENTS:

In order to maintain the exclusivity of the honor and not work through the pool of candidates too quickly, the Committee recommends that the Mayor and Council adopt two new honorees each year.

Regarding the addition of Mayor Burhans to the database, the Committee estimates that he will likely appear on its "short list" of recommendations in 2017 or 2018.

The Committee's recommendations are non-binding on the Mayor and Council. The elected

body can select any person meeting the adopted criteria, as determined by the Committee and entered into the database.

A copy of the criteria and the database updated to 2016 is attached for your use.

<u>Memorial Park: "Circle of Achievement"</u> <u>STANDARDS FOR INDUCTION</u>

GOAL: Inductee Review Committee will review potential inductees. The overall intent of the "Honor Wall" is to include citizens that reflect the full range of categories and represent a cross section of our community.

1. General Requirements

- A. Posthumous The candidate shall have been deceased for a period of at least 20 years, for the purpose of ensuring the person's notoriety and contributions have withstood the test of time.
- B. Residency or Relevance The candidate shall have lived in Hagerstown as it legally existed at the time the candidate lived in the City, owned a business in the City, or made major contributions to the City in their lifetime.

2. <u>Categories for Consideration</u>

A. Elected or Appointed Official and Officers of the Judiciary:

Elected or appointed officials as follows:

- (1) Statewide or National Office Any person who served as President or Vice President of the United States, as a member of the President's Cabinet, or as the governor of any state or territory, or as Lieutenant Governor, Attorney General or Comptroller of Maryland.
- (2) Elected Federal Legislative Office Any person who served in the United States Senate or United States House of Representatives, provided that the candidate can be demonstrated to have made extraordinary contribution to the Congress during his or her service.
- (3) Hagerstown Municipal Office Any person who served as mayor or city councilmember whose direct achievements can be specifically identified as having a direct and critical impact on the growth and development of the City.
- (4) Judiciary Jurists known for decisions or acts of national significance in the judicial history of the United States.

B. Civil Rights, Faith Community, Education and Science

Any person whose efforts and achievements are:

- (1) Widely recognized as critical and significant in securing the civil rights of Americans. Those whose work was at the national level need to be demonstrated that their work was significant at the national level. Those whose work was at the state level need to be demonstrated that their work was significant at the State level.
- (2) Extraordinary in promoting and developing the provision of education and/or science to the Hagerstown community or another location and the direct results of their efforts are ongoing and evident in that community.
- (3) Extraordinary contributions from a member of the faith community and the direct results of their efforts are ongoing and evident in that community.

C. Literary, the Arts and Sports

Any person whose works include:

- (1) Books, publications or other significant media contributions widely recognized as significant works.
- (2) A career in the performing or visual arts whose body of work is known nationally and is generally viewed as having achieved significant stature in their chosen art.
- (3) A professional sports person who is widely recognized as having achieved the pinnacle of their sport and is widely recognized within that sport's community.

D. Military

For achievement in the military service of the United States from 1775 to the present, and/or in the service of the Confederate States during the Civil War, and/or service in His Majesty's forces prior to 1775, or as a civilian in a military event as follows:

- (1) Flag Officer Any person who achieved the rank of major general in the Army, Marine Corps or Air Force, or rear admiral (upper half) in the Navy or Coast Guard, including the "regular" service, National Guard, reserves, home guard or militia.
- (2) Decoration and Heroism Any person who has been awarded:
 - (a) The Medal of Honor, or
 - (b) The Army Distinguished Service Cross (or equivalent decoration in parallel branches), or
 - (c) Two or more Silver Star Medals.

For acts of valor prior to the Civil War (in the case of the Medal of Honor) or prior to 1917 in the case of the Distinguished Service Cross or the Silver Star Medal, the Committee may consider candidates that, in its opinion, qualified for such awards prior to their adoption upon positive recommendation from military historians.

- (3) Prominent Event and Unique Achievement Any person who actively participated in and distinguished themselves in a military engagement of significant historic importance among a small or limited body of combatants or relevant participants (ex. someone who fought at the Alamo).
- (4) Record of Extreme Service Any person who maintained a career of 35 or more years of service in the military, over three or more war periods, including combat service in at least one war.
- (5) Innovation Any person who, while in military service, developed, promoted or otherwise was directly responsible for innovations in the evolution of military doctrine or science.
- (6) Any person who, as a civilian, participated in a significant military event in Hagerstown or elsewhere in such a way that this person showed conspicuous bravery and/or their actions materially affected the outcome of the military event.

E. Business and Industry

- (1) Any person who invented or developed something that has resulted in significant changes to an industry, field or classification of products or services and results in changes in the lives of Americans in their daily or professional lives.
- (2) Any person who developed a business or industry in the Hagerstown area that directly impacted the growth, development or reputation of the City.
- (3) Any person who, through actions or influence, affected significant historical events that impacted the commercial, diplomatic or governmental development of the United States.

Byron and Sons Tannery in Williamsport and president of Hagerstown Shoe and Legging Company, which was a very large manufacturer in Hagerstown.

Commanded USS <i>Ontario</i> in the Second Barbary War. Served as "second" to Commodore James Barron during the duel which resulted in the death of Commodore Stephen Decatur.
Sherman Mills Fairchild (1896-1971)	E(1) E(2)	Non resident	Head of Fairchild Aircraft during the mobilization for World War II. Fairchild Aircraft created the "Hagerstown System" of using smaller regional manufacturers to supply plant.
Donald MacNeil Fairfax (1821-1894)	D(3)	South Prospect	Admiral, US Navy. Liberated 705 slaves bound for the west while serving as executive officer of the USS <i>Constellation</i> . Personally involved in the "Trent Affair" while executive officer aboard USS <i>San Jacinto</i> (1861 naval event that nearly led to war with Britain). Captained US Navy ironclad monitors in attacks on Charleston and Fort Wagner, SC.
George Leonard Fisher (1846-1927)	D(4)	South Potomac	Enlisted in the Union army at Hagerstown at age 16. Captured at Laurel Hill. Discharged at 18 as a former POW. Enlisted in the US Army in 1866, serving until 1879, and was involved in the occupation of the south during reconstruction and served in the (Ute and Nez Perce) Indian Wars. Joined Hagerstown's national guard company in 1880, rising through the ranks, and served as captain during its mobilization for the Spanish American War. Retired in 1905, but was recalled during World War I to serve as an instructor for the home guard. Russell Hartle (1889-1961)	D(1), D(3)	Oak Hill Avenue	Major General, US Army, commander of the Fifth Corps. Deputy Commander of US forces in Europe in 1942-43. Led first US troops to arrive in Britain after the US entered the war.

Augustine Smith Mason (1834-1911)	D(3), D(5)	Summit Avenue and West Washington Street	From 1863 to 1865, served as the Chief Surgeon of the Military Department of Richmond, responsible for the care of tens of thousands of sick and wounded Confederate soldiers and Union prisoners of war, having to manage in the face of major shortages of supplies brought about by the Union blockade of Confederate ports. Mason was a prominent Hagerstown doctor for 45 years after the war.

Resigned in 1862 to accept captain's commission in the Union army - Company A, 7^{th} Maryland Infantry. In 1864, Mobley displayed conspicuous bravery at the Battle of Weldon Railroad by rescuing his regiment's flag from possible capture when the members of the color guard had been shot down in the battle. 1. Background

Our parks provide the public with many areas where they can view wildlife, natural resources, recreation programs, park activities, or simply enjoy the outdoors. Providing additional seating and tree canopy through <u>private</u> donations benefits park users, reduces costs for the City, and provides the public with opportunities to commemorate life events. Each year the City spends over \$10,000 on replacing or installing new benches and we are constantly adding new trees to the park system.

Staff is suggesting the City accept donations from the public for the installation of memorial benches and/or trees in designated areas throughout the Parks system. We became aware of programs that other communities do to allow people to purchase memorial trees or benches; effectively creating a "win-win" for the donor and the City. The main goal of the program is to beautify and improve our parks.

2. M&C Action Requested

Review the attached brochure and offer input. We would suggest Council formally approve the program at a Regular Session when ready.

3. Discussion

Staff researched best practices from other programs, primarily using the National Recreation and Parks (NRPA) forums to see what worked well in other communities and where they encountered issues that had to be addressed. Based on this research, we created the attached brochure and it outlines the program and guides the donors through the process. Our goal is to keep the process simple but complete enough to protect our interests.

Staff will be available at the next work session to discuss this proposal.
